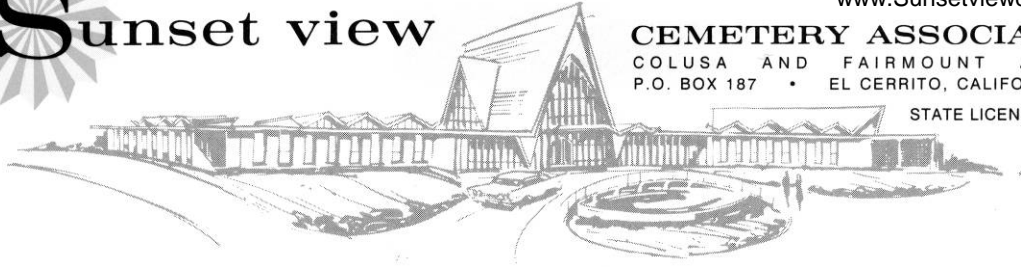

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

Complete Funeral Facilities within One Gate . . .

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

- 1. **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD** \$1,500.00
 This is a basic fee that we charge every family for our professional expertise in assisting them with their preferences. It also includes a proportionate share of the taxes, licenses, utilities, and business expenses required to serve the public. Our charge includes consultation with the family or responsible party, administrative and clerical services, coordinating service plans with cemetery, crematory, clergy or other parties as required. Preparation, filing and securing of necessary notices, authorizations and permits.
 This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)
- 2. **TRANSFER OF REMAINS TO THE FUNERAL HOME** \$375.00
 For travel outside of our local perimeter of 20 miles, please add \$3.00 per mile one way.
- 3. **EMBALMING** \$500.00
 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
- 4. **OTHER PREPARATION OF THE BODY**
 - A. Use of refrigeration equipment if remains are not embalmed (add 100.00 per day after 10 days) ... \$300.00
 - B. Dressing and cosmetology of embalmed remains \$150.00
 - C. Disinfection and dressing of unembalmed remains \$200.00
 - D. Preparation of unembalmed remains for identification without dressing (See below) \$ 0.00
 - E. Preparation of unembalmed remains and private family viewing (See below) \$200.00
 - F. Use of facilities and staff assist for autopsy by your Pathologist \$300.00
- 5. **USE OF FACILITIES AND STAFF FOR VIEWING** (per day or fraction thereof) ... \$300.00
- 6. **USE OF FACILITIES AND STAFF FOR FUNERAL CEREMONY** \$600.00
- 7. **USE OF FACILITIES AND STAFF FOR MEMORIAL SERVICE** \$600.00
- 8. **USE OF EQUIPMENT AND STAFF FOR GRAVESIDE SERVICE** \$150.00
- 9. **ADDITIONAL STAFF SERVICES**
 - A. Use of Equipment and Staff for service at Church or other facility \$600.00
 - B. Weekend Service or Evening Service (after 5:00 p.m.) \$700.00
 - C. Crematory charge for cremation process \$450.00
- 10. **AUTOMOTIVE EQUIPMENT**
 - A. Funeral vehicle to transport casket within Sunset View Cemetery \$100.00
 - B. Funeral vehicle to transport casket to church or other cemetery \$300.00
 - C. Limousine serving our local service area (After four hours please add \$50.00 an hour) \$300.00
 - D. Flower car to transfer floral tributes to church or other cemetery \$150.00
 - E. Delivery to or removal of remains from airport \$375.00
 - F. For travel outside our local perimeter of 20 miles please add \$3.00 per mile one way per vehicle.

It is the policy of Sunset View Cemetery Association, for health and sanitation reasons, to require that embalming be performed on remains to be viewed, other than by private family or for the purpose of identification, or remains that are, at your request, casketed and placed in a state room or chapel for visitation or services prior to the day of the funeral ceremony.

We request that remains to be viewed for the purpose of identification be viewed, by no more than two people designated by the family, as soon as possible after the transfer of the remains to the funeral home is completed. Special conditions apply.

A private family viewing of unembalmed remains permits up to ten family members to be with the deceased for up to fifteen minutes in a private room. Special conditions apply.

State law requires that remains held more than 24 hours must be embalmed or refrigerated.

COMPLETE TRADITIONAL FUNERAL SERVICE \$3,675.00

This fee contains all of the items normally selected for a traditional funeral service and includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, and cosmetology, one day's use of facilities for viewing or visitation, use of facilities for funeral ceremony during normal business hours (between 9:00 a.m. and 5:00 p.m.), and funeral vehicle to transport casket within Sunset View Cemetery for a graveside committal service.

This fee does not include merchandise, legal filing fees, cash advances, accommodation charges, staff overtime (if applicable), or transportation outside our cemetery or beyond our local perimeter of 20 miles.

(Local Limousine for family please add \$300.00 for up to four hours use.)

ALTERNATIVE SELECTIONS

A. FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$2,911.00

This fee includes basic services of funeral director and staff and overhead, transfer of remains to the funeral home, embalming and dressing of remains, motor equipment to local airport or other local point of transportation and health department fee for filing the permit for disposition. This fee does not include casket, certified shipping container required by airlines, viewing, funeral ceremony, shipping charges or additional cash advance items.

B. RECEIVING REMAINS FROM ANOTHER FUNERAL HOME \$1,986.00

This fee includes basic services of funeral director and staff and overhead, transfer of remains from local airport, delivery of remains to cemetery and health department fee for filing the permit for disposition. This fee does not include viewing, funeral ceremony, casket, cemetery or crematory charges, or additional cash advance items.

C. DIRECT CREMATION AVAILABLE FROM \$1,961.00 to \$2,835.00

This fee includes basic services of funeral director and staff and overhead, transfer of remains to the funeral home, use of refrigeration equipment, crematory charges, and health department fee for filing the permit for disposition. This fee does not include additional merchandise, embalming, viewing, funeral ceremony, additional cash advance items or disposition of the cremated remains.

- A. Direct cremation with container provided by purchaser. \$1,961.00
- B. Direct cremation with corrugated cardboard alternative container "A" (includes tax) \$2,042.94
- C. Direct cremation with basic gray fiberboard alternative container "B" (includes tax) \$2,124.88
- D. Direct cremation with standard light wood composite alternative container "C" (includes tax) \$2,234.13
- E. Direct cremation with shaker light pine laminate alternative container "D" (includes tax). \$2,616.50
- F. Direct cremation with pacific medium pine laminate alternative container "E" (includes tax) \$2,835.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container "A" that we provide is corrugated cardboard.

D. IMMEDIATE BURIAL AVAILABLE FROM \$2,286.00 to \$3,241.94

This fee includes basic services of funeral director and staff and overhead, transfer of remains to the funeral home, use of refrigeration equipment, delivery of remains to cemetery, and health department fee for filing the permit for disposition. This fee does not include additional merchandise, embalming, viewing, funeral ceremony, additional cash advance items, or cemetery costs.

- A. Immediate burial with casket provided by purchaser. \$2,286.00
- B. Immediate burial with gray cloth covered number 1 casket (includes tax) \$3,241.94
- C. Services listed above plus additional cost of other casket selected. \$2,286.00
